#### 1. GENERAL FUNCTIONS

##### 1.01 Call to Order

##### 1.02 Truth in Taxation Hearing and Public Hearing

Dr. Rottweiler stated that, pursuant to A.R.S. §15-1461.01, the Governing Board shall hold a Truth in Taxation Hearing and Public Hearing. The Truth in Taxation Hearing and Public Hearing notice was appropriately published on April 21, 2017 and May 5, 2017, in the Sierra Vista Herald, as the paper of record, as well as in the Douglas Dispatch and San Pedro Valley News, as a courtesy. ##### 2.01 Approval of Increase in the Primary Property Tax (FY 2017-2018)
