2.04 Multi-Function Printer/Copier Leasing Services

The administration requested the Governing Board adopt a motion to authorize the College President or designee to sign an agreement for copier leasing services to Fruth Group for a period of five years at a cost of \$79,896 per year, or \$399,480 for five years. It includes 40 machines, and maintenance and supplies will be at the cost of the college. It is under the cost of the current contract.

Mr. Quinn moved, and Mr. Nelson seconded a motion authorizing the College President or designee to sign an agreement for copier leasing services to Fruth Group for a period of five years at a cost of \$79,896 per year, or \$399,480 for five years. There was no further discussion and the Governing Board approved with David DiPeso, Don Hudgins, Tim Quinn, Dennis Nelson, and Jane Strain all voting aye. **MOTION CARRIED**.
