<u>Position Summary:</u> The Accounts Payable Lead Technician is responsible for processing accounts payable transactions, including ensuring accurate and timely vendor payments in conjunction with outstanding vendor relations, assisting staff with travel processes and payments, and ensuring compliance with all related state and college rules, regulations, policies, and procedures.

<u>Essential Functions</u>: As defined under the Americans with Disabilities Act, may include any of the following tasks, knowledge, skills, and other characteristics. This list is ILLUSTRATIVE ONLY, and is not a comprehensive listing of all functions and tasks performed by incumbents of this class.

<u>Duties and Responsibilities:</u> Within the scope of college policies and procedures, this position:

Processes vendor and student payables and associated transaction tax functions for the District, ensuring appropriate documentation is received for support of timely and accurate payments to comply with all college, state, and federal policies, procedures, regulations, and laws; investigates and resolves vendor and student payables issues as needed

Assists with the travel authorization process, including training and expense processing for the District, to include purchase card use through reference material; assists employees and departments with questions and training, as requested

Creates and shares a variety of data reports for administrative and financial analysis, recommends process improvements and/or policy changes as appropriate; compiles data to prepare statistical summaries, prepares special or recurring reports for administration as necessary; maintains complete and accurate records

Prepares annual tax reporting documents and files in a timely manner

Performs other related duties as assigned

<u>General Expectations:</u> Employees are expected to accomplish assigned duties in an efficient, effective and competent manner and to strive for improvement and excellence in all work performed. Additionally, employees must understand the comprehensive role of the community college and cooperate and work harmoniously with students, faculty and staff, and the public. Ability to analyze problems, identify solutions and take appropriate action, resolve problems using independent judgment and decision-making processes

Ability to establish and maintain effective working relationships with supervisors, other department staff, students and the public

Ability to work accurately, efficiently, and effectively with all types of data

Ability to maintain accurate office procedures

Work Environment: Work is primarily performed under general supervision. Incumbent generally performs work in a typical office setting with appropriate climate controls.

Physical Requirements: Essential functions of this position require: lifting, manual dexterity, ability to communicate.
