### Section 4 First Aid Measures

**Emergency and First Aid Procedures**

**Inhalation:** IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing.

## Steps to Take in Case Material Is Released or Spilled:

Exposure to the spilled material may be severely irritating or toxic. Follow personal protective equipment recommendations found in Section 8 of this SDS. ## Environmental Precautions:

Avoid breathing material. Avoid contact with skin and eyes. Reduce airborne dust and prevent scattering by moistening with water. Ventilate the area by opening door and/or turning on fans and blowers. Avoid runoff into storm sewers and ditches that lead to waterways. Absorb spill with inert material (e.g., dry sand or earth), then place in a chemical waste container.
