<u>Position Summary:</u> The Department Assistant Facilities and Maintenance is responsible for providing administrative support to facilities staff at assigned location and department leadership under the direction of the Facilities Office Supervisor, providing excellent customer service in a helpful and cheerful manner.

Essential Functions: As defined under the Americans with Disabilities Act, may include any of the following tasks, knowledge, skills, and other characteristics. This list is ILLUSTRATIVE ONLY, and is not a comprehensive listing of all functions and tasks performed by incumbents of this class.

Duties and Responsibilities: Within the scope of college policies and procedures, this position:

- Performs exceptional customer services for students, employees, and the public by serving as department receptionist; responds to calls and routes as appropriate, greets visitors and directs as required; prepares, receives and distributes letters, memoranda and other correspondence; logs, tracks and distributes documents processed by the department; manages department calendar
- Coordinates work requests to be completed by facilities maintenance technicians on a case by case basis for college faculty and staff; closely monitors work orders to ensure customer satisfaction and project completeness
- Serves as the point of contact for all assigned campus vehicle assignments utilizing the electronic system; processes fleet vehicle requests, tracks mileage, and alerts supervisors to vehicle problems; maintains inventory of campus keys issued and returned; maintains department's current physical inventory
- Provides clerical and organizational support to department staff; maintains and tracks information, performs data entry and verification, ensures data integrity, processes mail and correspondence for department staff and students who live on campus, compiles periodic reports, maintains a calendar of department activities, performs routing, copying and filing, maintains office supplies inventory
- Assists with the maintenance of department fiscal records; processes of purchase and travel requisitions, purchase orders, invoices, travel vouchers, etc. and reconciliation of budgets, investigates vendor issues as needed; reconciles and files purchase card transactions for department staff as required

Performs other related duties as assigned

<u>General Expectations</u>: Employees are expected to accomplish assigned duties in an efficient, effective and competent manner and to strive for improvement and excellence in all work performed. Additionally, employees must understand the comprehensive role of the community college and cooperate and work harmoniously with students, faculty and staff, and the public. - Ability to work under pressure with frequent interruptions

<u>Work Environment</u>: Work is primarily performed under general supervision. Incumbent generally performs work in a typical office setting with appropriate climate controls.

Physical Requirements: Essential functions of this position require: lifting, manual dexterity, ability to communicate.

- Sedentary Work: Exerting up to 10 pounds of force occasionally and/or a negligible amount of force frequently or constantly to lift, carry, push, pull or otherwise move objects, including the human body; involves sitting majority of time; walking and standing are required only occasionally and all other sedentary criteria are met
- Mental Application: Utilizes memory for details, verbal instructions, emotional stability, critical thinking, adaptability and creative problem-solving skills are important
